 - (iv) any quality assurance programme that was applied during the *manufacture or installation / manufacture of modified components or major modification of the amusement ride; and
 - (v) any other direction given by the Commissioner in respect of the *installation / modification works, where applicable; and
- b) where any deviation from the authorised design and specifications or the authorised *installation / modification method and programme *of the amusement ride / for the major modification of the amusement ride had been approved by the Commissioner -

 - (ii) the conditions imposed by the Commissioner in respect of the deviation were complied with.
